Program Highlights

Forest Health Protection

Asian longhorned beetle was found in Tate township, Clermont County in 2011; it is a major threat to hardwood forests and to the State's \$5 billion nursery industry. The Department of Agriculture continued treatment efforts in the Slow the Spread transition zone with four treatments occurring in 2018. Hemlock woolly adelgid treatments continued in Jackson and Lawrence Counties.
