Dear Mr. President:

The National Association of State Foresters (NASF) and its members congratulate you on your successful campaign for our country's highest office. Today we request your leadership and pledge our support in addressing some of the most pressing concerns facing our nation today, including – but certainly not limited to – climate change, wildfires, and America's economic recovery.

Established in 1920, NASF is a non-profit organization composed of the directors of forestry agencies in all 50 states, eight U.S. territories, and the District of Columbia. Our members directly manage and protect state and private forests – which encompass nearly two-thirds of the nation's forests – and regularly assist in the conservation of federally managed forests and grasslands.

Perhaps no partnership has been more important in the history of U.S. forestry than the partnership between state foresters and the USDA Forest Service. State forestry agencies and the USDA Forest Service share the same fundamental goal – healthy, resilient, and productive forests – and the same core responsibility – to protect, conserve, and enhance forests.

Since the early 1900s, Congress has recognized and reinforced this natural government-to-government partnership for America's forests with landmark legislation, including the Weeks Act of 1911, the Clarke-McNary Act of 1924, the Cooperative Forest Management Act of 1950, the Cooperative Forestry Assistance Act of 1978, and the 1990 and 2008 Farm Bills. Today, state forestry agencies are the leaders in supporting forest management on all land ownerships and the primary deliverers of federally supported forestry assistance nationwide.

The COVID-19 pandemic has had a devastating effect on the nation's economy, negatively impacting many state forestry agency budgets. We look forward to working with your administration and congressional leaders to ensure state forestry agencies are able to continue supporting the forestry sector, local jobs, and economic recovery.
