## **Shipping Information**

Shipments will be accepted 21 days prior to group arrival date. Freight received earlier than 21 days will be subject to a weekly storage fee of thirty percent of total handling fees.

Your packages need to arrive at least 7 days in advance of your group's arrival date. Orders and/or shipments received less than 7 days before group arrival date are subject to a 30 percent special handling fee.
